The study is funded by the Bill & Melinda Gates foundation, and supported by the Government of Chhattisgarh.

The study is funded by the European Research Council, and cash transfers stop in December 2023.

The objective of the study is to develop a standardized measurement for the influence of norms on female laborforce participation that is grounded in the normative complexities within and across India, Bangladesh, and Pakistan. Evidence from this study will be critical to design effective research and policy interventions to improve female laborforce participation, rebalance care work within households, and prevent intimate partner violence. This study is in collaboration with the American Institutes for Research in the US, and is funded by the World Bank.
