B. PROFESSIONALL EXPERIENCE:

1. Health Resources and Services Administration (HRSA), Maternal and Child Health Bureau:

Director, Division of Healthy Start and Perinatal Services: September 2012 to April 2017

In this position, I was responsible for managing the division of 28 staff members and lead the "transformation" and implementation of the National Healthy Start Program with a budget of \$115 million and 100 grants to community based organizations in 37 states and the District of Columbia (grants ranging from \$750,000 to \$2 million). The program works with grantees in high risk communities to identify and recruit high risk women, connect them with the health care system and ensure care coordination and continuity of care. During my 5 years leading the program, we "transformed" the 25-years old program into an evidence-based program. Grantees are held accountable to the content and quality of their work as well as the outcome of their activities. We also expanded services from serving only high-risk pregnant women and infants to serving all women of reproductive age and from focusing on pregnancy through 40 days after delivery to focusing on social determinants of health and working closely with other sectors such as labor, education, social services, housing etc. Grantees are held accountable and are expected

to serve as a backbone organization for their community, identify and implement evidence-based interventions, collect client level data for quality improvement, and evaluate their program on an ongoing basis. During my five years with the program, we also established a "community health worker" training program to ensure that all employees of the grantees are competent and qualified. The EPIC Center (www.healthystartepic.org) was established as a resource center to provide technical assistance to all grantees through multiple mechanisms to assist them in the proper implementation of the program.

In addition to the Healthy Start Program, I led the establishment of several initiatives including the National Maternal Health Initiative, Guidelines for Well Women Care, a Breastfeeding Initiative, a Fatherhood Initiative, and the Inter-conception care Implementation Program which includes developing ICC Implementation toolkits.
